# **CHILDREN IN OUR SCHOOL**

An information leaflet for Visitors/  
Parents and Carers.

The Nelson Thomlinson School recognises the importance it gives to all pupils' welfare and Safeguarding.

The purpose of this good practice leaflet is to share with you our excellent safeguarding practice and the responsibility we have to Safeguard all NTS pupils.

- We work to establish and maintain an ethos where children feel secure and will be listened to in an open positive atmosphere. This includes activities within the Curriculum: PSHRE, SEAL, 2T-Tutoring and Peer mentoring in school; e.g. School Council.
- We ensure the children know that they can approach any member of staff if they are worried or in difficulty.
- We actively seek the views of children, listening to them and involving them in decisions about their education.
- We will make any referrals necessary to ensure the well being of all children is safeguarded.

***“No single professional can have a full picture of a child’s need and circumstances and, if children and families are to receive the right help at the right time, everyone who comes into contact with them has a role to play in identifying concerns, sharing information and taking prompt action.”(Working Together to Safeguard Children, HM Government 2018)***

## Roles and Responsibilities

Staff in school are in a good position to keep a watchful eye on children and their safety and to protect them from harm. If staff have concerns they have a duty to inform **a member of the Safeguarding Team.**

## The Role of the Governing Body

Safeguarding children is a ‘collective responsibility’ for the whole of the Governing Body.

Every school should have a Nominated Governor for Safeguarding; Child Protection. In NTS this is Mrs Fuggle. They can be contacted by emailing the Clerk to the Governors:
